We look forward to the coming years, to continue to provide medical support to the Type1D children and provide them with all the support to be able to lead a healthy and fulfilling life.

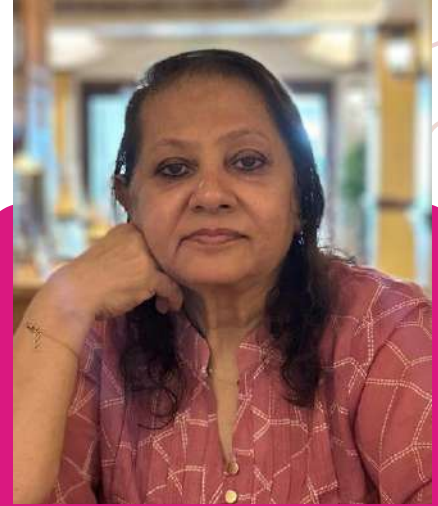

We are pleased to present the Annual Report for the fiscal year 2023-2024, highlighting the impactful work of the Nityaasha Foundation. The Foundation has celebrated 10 years of delivering holistic services to children and young people with Type 1 Diabetes from economically weaker sections of society.

The Nityaasha Foundation was established through the philanthropic vision of Mr. Farook Merchant and Mrs. Nasima Merchant and Messung Group of Companies, with a Managing Committee comprised of eminent and experienced members of society. It is a registered charitable trust and commenced its operations on 25th July 2013 in Pune.

The foundation primarily focuses on children and young people living with Type 1 diabetes between the age of 0-23 years of age from the economically weaker section of society. Type 1 diabetes, also known as juvenile diabetes, is an auto-immune disorder where the body's immune system destroys the insulin-producing cells in the pancreas.

The foundation supports them by providing free medical aid and taking care of their annual pathology tests, annual check-ups, and social counselling, along with continuous monitoring and education through regular home visits and follow-up phone calls which enables them to manage this disorder hence leading them to a normal life. Presently, we have 151 Type 1 diabetes children under our care.

Nityaasha works closely with Endocrinologists and Diabetologists from various hospitals in and around Pune, Mumbai, Sangli, Ahmednagar, Beed, Nashik, Thane, etc. We have started a series of sessions on continuous medical education (CME) to help T1DM children and parents understand the concept of disorders and their day-to-day management for a better quality of life.

On behalf of the Nityaasha Foundation, we extend our sincere gratitude to our generous supporters, donors, and volunteers who have made this work possible. Your unwavering belief in our noble cause has enabled us to touch the lives of Type 1 diabetes children, young people, and their families, providing them with hope, care, and a brighter future.

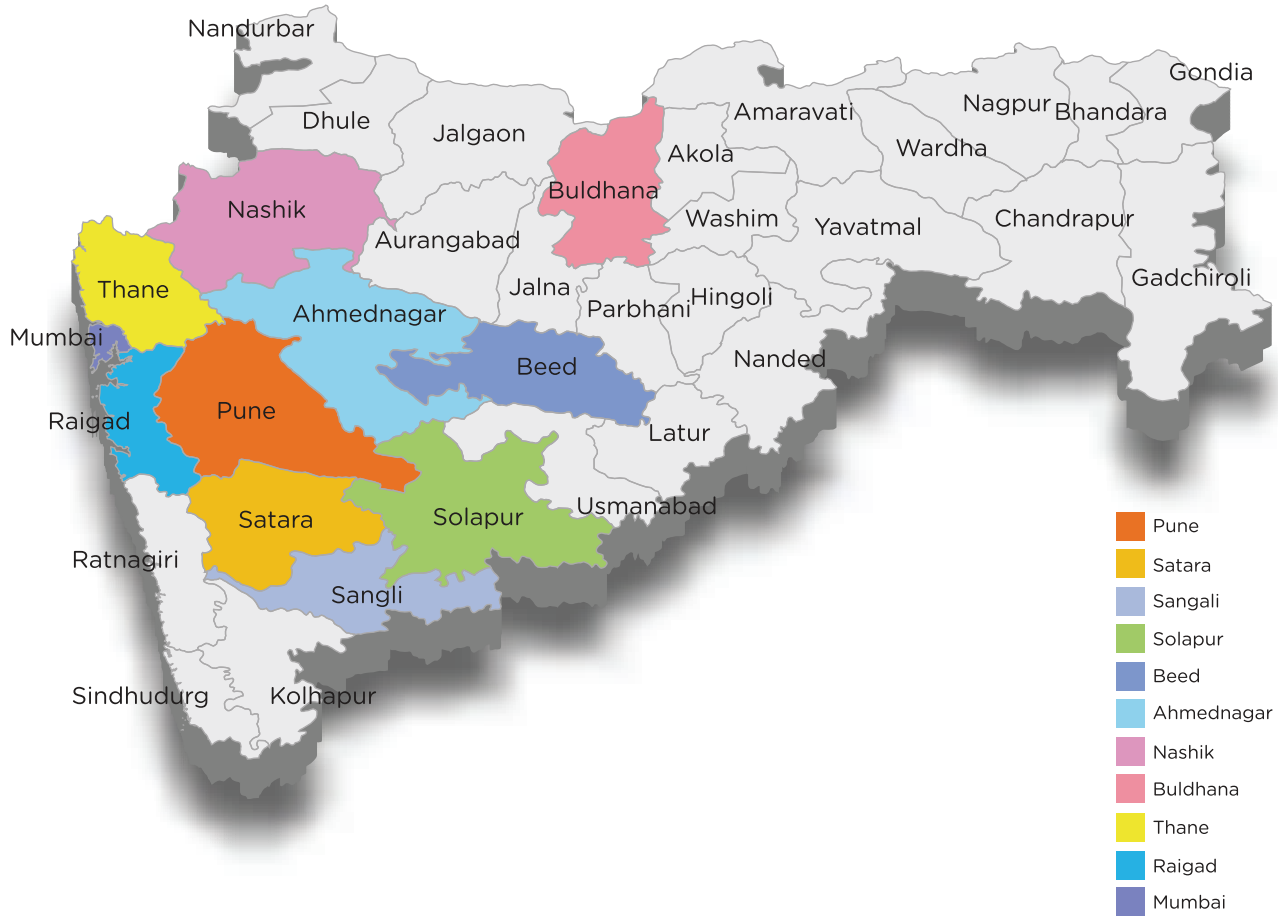
**MONITOR** the child's health on a continuous basis by making periodic home visits, school visits, and follow-up calls.

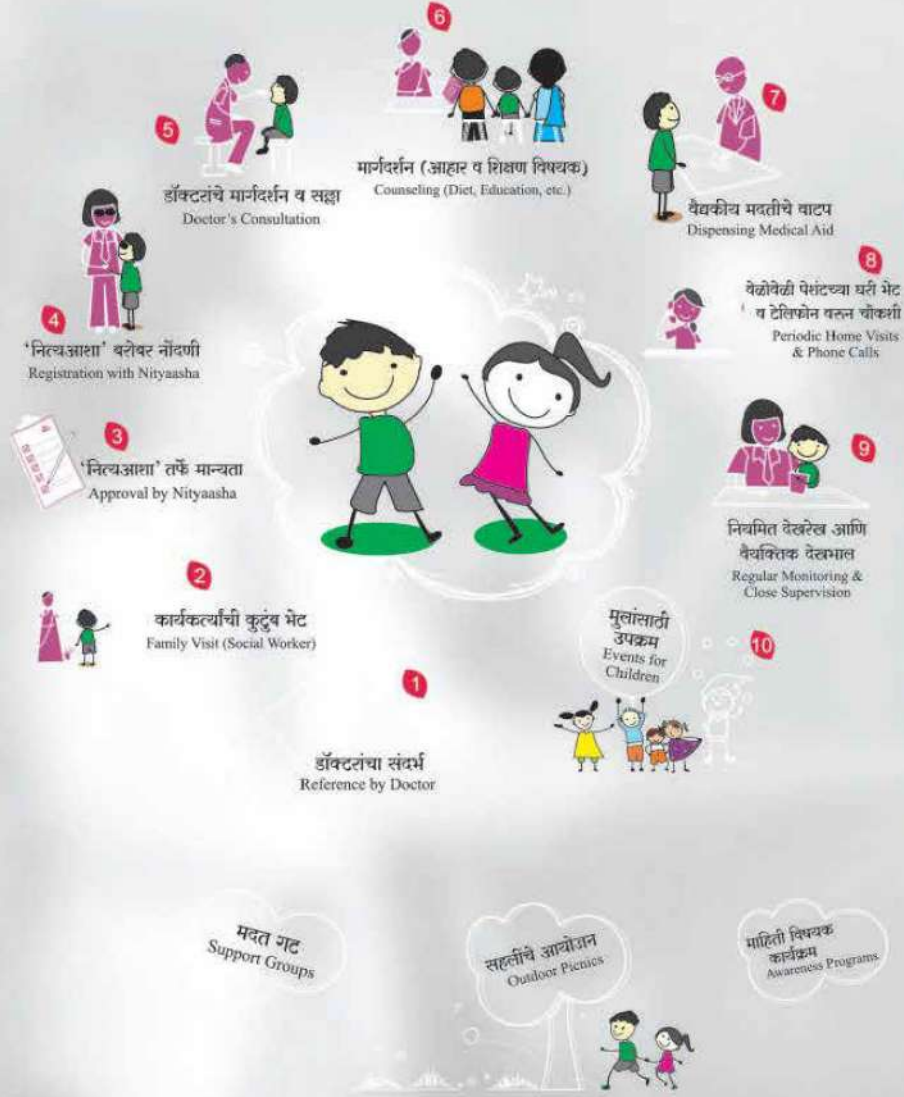

A distinctive feature of Nityaasha is the team's commitment to conducting home visits to monitor the daily management of Type 1 Diabetes in children and young adults. These visits focus on diet and social counselling, insulin storage, blood sugar level monitoring, and raising awareness about Type 1 Diabetes.

Children enrolled in Nityaasha are scheduled to collect medical aid every two months, with distribution days occurring twice a week on Tuesdays and Thursdays. Special cases like children in the "Red Category" who require closer monitoring may visit the centre monthly. Children who travel long distances may sometimes receive medical aid for three months. No. of children for a centre visit for Psycho-Social Counselling, Education of day-to-day T1D management at home and Disbursement of Medical Aid. Insulin was dispensed from the Medplus pharmacy - Viman Nagar Drug Pharma store - Viman Nagar Pune.

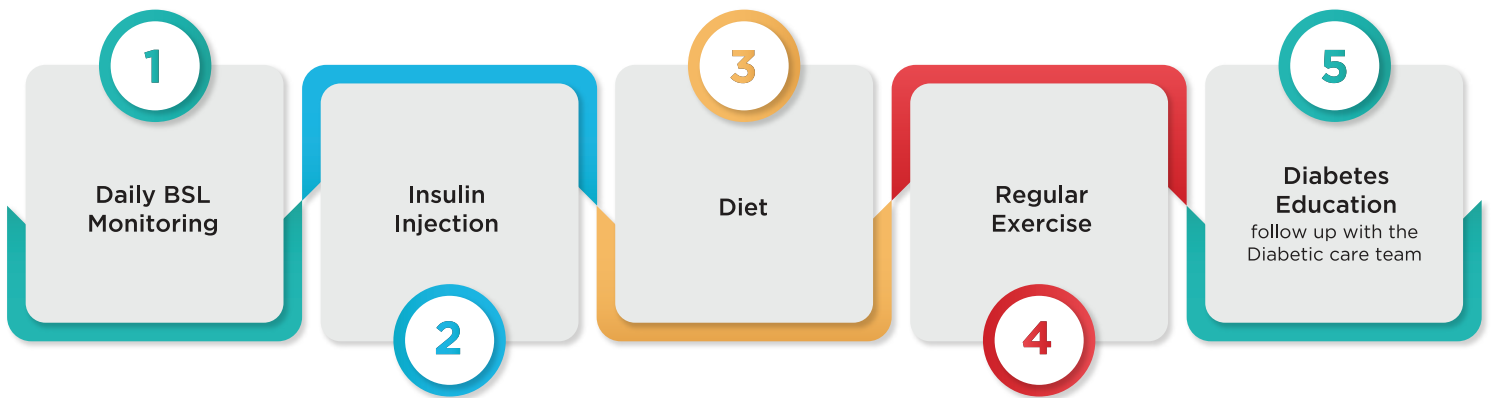
## 2. HIGHLIGHT MONITORING ACTIVITIES:

### Half yearly pathology test & annual pathology test (Red Category - HbA1c above 10%):

- Our annual pathology tests are scheduled for December and January, and half-yearly tests are conducted in June and July.

- Ongoing continuous monitoring strategies are planned for Red Category children, focusing on 5 pillars of diabetes management:



Some action taken for the Red category children:

- Nityaasha schedules special home visits for children with HbA1c levels greater than 10%. During these visits, our MSW cross-checks daily blood sugar levels using the glucometer and glucose diary, in the presence of the child and their parents. Additionally, the MSW assesses insulin storage, injection sites, insulin dose adjustments, dietary habits, and daily activity levels.
- For children in the 'Red category,' we perform additional HbA1c tests.
- We also do the specific tests for the T1D children as and when recommended by the doctors.
- Regular follow-up calls: Nityaasha team gives regular follow-up calls for children in the red category.
- WhatsApp Group for Daily monitoring: Groups are created by the team and ask them to share their daily Glucose diary & dietary intake. Nityaasha team also regularly shares do & don't in Diabetes, diabetic recipes, educational information in the group, etc.
- Peer group counselling support group: Nityaasha facilitates the formation of peer support groups for individuals with Type 1 Diabetes. Peer group counselling sessions are conducted during home visits by young adolescents with Type 1 Diabetes who are phased out and work as volunteer services.

- Educational Session by the doctor: Nityaasha Foundation in coordination with Kalyani Clinic, Dr. Arundhatee Khare conducted the 7th Diabetes Education Series, focusing on the importance of maintaining normal blood sugar levels (BSL) and target HbA1c levels to prevent diabetes complications. The session covered various topics related to Type 1 Diabetes self-management, including: Types of Insulin, Insulin storage and technique, Carbohydrate counting calculations (IS Ratio and IC Ratio), Insulin dose titration, Hypoglycemia and Hyperglycemia management, Exercise with diabetes, and Sick day management.

## 4. OTHER ACTIVITIES:

### April 2023:

- On 8th April 2024, a CME (Continuing Medical Education) session on "Exercise and Sick Day Management" was held in coordination with Kalyani Endocrine, Dr. Arundhatee Khare. 19 children with Type 1 Diabetes and their parents attended the session.
- Mr. Farook Merchant, Founder and Trustee of Nityaasha Foundation, has granted permission to increase the intake capacity of Type 1 Diabetes children in Nityaasha from 150 to 160.

### May 2023:

- On 17th May 2024, In collaboration with Gyaan Ruchi, an online awareness session on "Diabetes and Diet" was conducted. Mrs. Subhashini led the session, and 26 women from Gyaan Ruchi participated.
- 8 Nityaasha children appeared this year in the 12th Board exam, and they all cleared the exam with flying colours.

### June 2023:

- On 8th June 2023, Ms. Subhashini attended the Pan India Symposium 2023 organized by HCL TechGrant - HCL Foundation at the S.P. Jain Institute of Management in Andheri (West), Mumbai. This event provided a valuable opportunity to learn about proposal writing and concept notes for organizations.
- On 21st June 2023, Mr. Farook Merchant and Mrs. Subhashini participated in a Zoom meeting organized by the T1D community for one-on-one calls with grantees. During the meeting, they interacted with Betsy Ingalls and Sierra Fox-Woods, Program Officers at the T1D Community Fund, and discussed the ongoing activities of Nityaasha.

### July 2023:

- Coordinated with LFAC for Accu-chek strips, lancets and glucometers, and on 3rd July 2023, received the medical aid cost of Rs. 13,47,968/- from Roche Diabetes Care Pvt. Ltd. for one year of stock for 140 Type 1 Diabetes children and young adults.
- On 5th July 2023, received 105 Basaglar packs (525 cartridges) from KNK agencies through LFAC - Direct Relief Fund and the total cost is Rs.28,25,93/-.
- Mr. Yogesh Sarode, an MSW was selected for the post and will join from 3rd August 2023.



- On 21st July 2023, attended a stakeholder meeting for T1D children in India on Zoom organised by Sanofi & People to People Health Foundation (PPHF), New Delhi.

The overall discussion and outcome of the task force group are:

1. Bring Type 1 DM into the public and political domain.
  2. Higher budgetary allocation for Type 1 DM interventions.
  3. Increasing access to affordable and quality medication for Type 1 DM.
  4. Increase community awareness and access to related services.
  5. Improve the health management information system to have better epidemiological data on Type 1 diabetes for better programming.
  6. Improve the supply chain for sustainable access to Type 1 Diabetes medicines and availability of diagnostics.
- On 25th July 2023, Nityaasha celebrated its 10th anniversary of providing services to individuals with Type 1 Diabetes from economically weaker sections of society. To commemorate this milestone, a cake was cut by Mr. Farook Merchant and Mrs. Nasima Merchant, the Founders and Trustees of Nityaasha, along with Mrs. Gulshan Mashkati, a Managing Committee Member. Twelve children visited the Nityaasha Center to collect medical aid and were given food packages. Greeting cards with mementoes were also sent to all the Managing Committee Members. We would like to express our sincere gratitude to all the well-wishers, donors, and doctors who have supported our cause, both directly and indirectly.

### **August 2023:**

- On 1st August 2023, attended an online meeting with Aditya Birla Health Insurance team, Sand Network team. Mr. Farook Merchant briefly explained the Nityaasha Foundation and its process for T1D children enrolment and the service provided. They were looking for collaborating a partner NGO for their campaign.
- A meeting with Dr. Meghna Chawla and her team along with the Nityaasha Team held on 7th August 2023. We have discussed all the children in the Red Category and what intervention we can plan for the T1D child and their caretaker.
- An orientation program for 8 MSW students from Tilak Maharashtra Vidyapeeth along with one staff visited Nityaasha Centre on 8th August 2023. The Nityaashaa Team interacted with them and informed them about the Nityaasha Foundation, history, Vision & Mission, process and role of MSW.
- On 14th August 2023, Mr. Krishna Jadhav attended a workshop on the Orientation of T1D in Schools and Teachers at KEM Hospital.
- On 21st August 2023, received 420 Basaglar packs (2100 cartridges) from LFAC - Direct Relief Fund and the total cost is Rs.12,58,702/-.

### **September 2023:**

- On 14 September 2023, attended the free webinar on “Translating 2022 ISPAD guidelines into practice - Real life scenarios: Managing diabetes in limited resource settings”.
- On 23rd September 2023, Diabetes Education session part 1 was conducted at Conference room Lunkad Sky Vista, Vimannagar. 23 T1D adolescents & youth along with their parents attended the session.

## October 2023:


- On 10th October 2023. Mrs. Subhashini attended the IDF online webinar Blue Circle Talks “Respecting Your Limits” focusing on Diabetes and mental health.
- On 17.10.2023, Ms. Subhashini & Ms. Hema attended Gyaan Ruchi “Preventive Health Check-up for Women at Deccan Gymkhana, Pune. 42 women health check-ups were done.
- The 2nd Diabetes Education session in collaboration with Kalyani Endocrine Clinic was conducted on 21.10.2023 at the Conference Room, Lunkad Skyvista. 29 T1D children along with their parents attended this session.
- Coordinated with children for the Pathology tests and 31 children completed tests i.e. HbA1c, TSH, Urine Routine Culture, Urine Albumin/Creatinine, etc.
- Online drawing competitions for T1D children and youth were organized with the subtheme: My favourite animal, Nature picture, Shri Ganesh picture for age group 4 to 10 years; My favourite festival, Save the tree, My school for the age group 11 to 16 years and My health is my responsibility, My dream (fantasy), Clean India for the age group 17 to 23 years. A total of 32 children participated in the drawing competition.
- Another event “Speech Competition – one minute talk” was organized with subthemes: My favourite game, Nutritious food, Good habits for age group 4 to 10 years, Importance of sports, Importance of Education, Health & hygiene for age group 11 to 16 years; Importance of yoga & exercise, G-20 (2023) / Chandrayaan, International Diabetes Day for the age group 17 to 23 years. 42 children and youth participated in the speech competition.

## November 2023:

- A preventive health check-up for the T1D caretaker of Nityaasha Children was organized on 09.11.2023 at Skyvista Conference Hall. In coordination with Prayas, women’s cervical cancer screening was done. Pathology test was done under A.G. Diagnostic Pvt. Ltd., the test package included a complete haemogram, TSH and HbA1c test were done. 53 women participated in this camp.
- The 3rd Diabetes Education session in collaboration with Kalyani Endocrine Clinic was conducted on 15.11.2023 at the Conference Room, Lunkad Skyvista. 25 T1D children along with their parents attended and the type of Insulin and its action was covered in this session.
- LFAC equipment approved by the LFAC for the Nityaasha Center were purchased and a reimbursement of Rs.78442/- was credited to Nityaasha’s account on 21.11.2023.
- On 23rd November 2023, Mrs. Subhashini was invited as a Chief Guest on the World Diabetes Day Program, an opening ceremony of the Type 1 diabetes parents support group initiated by the Department of Pediatric, Dr. D.Y. Patil Hospital & Research Centre, Pimpri.

## December 2023:

- On 6th December 2023 Dr. Laxmikant Palo, CEO of PPHF New Delhi, visited Nityaasha Foundation.
- Mrs. Subhashini and Mr. Krishna Jadhav attended the National T1D Conclave, held in Aurangabad on December 9th and 10th, 2023. The conclave served as a valuable platform



for the Type 1 Diabetes community to connect, share experiences, and learn from one another. It was an enriching experience that provided opportunities to explore new technologies and gain valuable knowledge about T1D management. By exchanging knowledge and practical experiences, we were able to foster collaboration and empower individuals living with Type 1 Diabetes.


Nityaasha Foundation was honoured to receive the Best Innovative Psychosocial Practices Award for its efforts to empower less privileged children and youth with Type 1 Diabetes Mellitus. This recognition serves as a motivation for us to continue our commitment to making a positive impact on the lives of those affected by this condition.

- On 12th December 2023, Dr. Sona Deshmukh & Ms. Ifra Yusuf from the PPHF team visited the Nityaasha centre for the implementing “Sanofi – Social Impact program for Type 1 diabetes project”. They also interacted with Type 1 Diabetes children and their family at the centre.
- On 22.12.2023, a session for diet & lifestyle management for the caregivers was conducted at Nityaasha Center. We have invited Dr. Radika Rawat for this session. 23 mothers of Type 1 diabetes children participated in the session.
- The 4th Diabetes Education session in collaboration with Kalyani Endocrine Clinic was conducted on 30.12.2023 at the Conference Room, Lunkad Skyvista. 25 T1D children along with their parents attended and the Carbohydrate Counting and Insulin dose titration were covered in this session.

#### **January 2024:**

- On 4th January 2024, a felicitation program was organized for Blue Brigade Sports Runners ladies, Mrs. Reema Mehta, Mrs. Manjit Kaur, and Mrs. Rimple Jain who finished their marathon from Saniwar Wada, Pune to The Gateway of India, Mumbai. They raised a fund of 1.5 lakhs for Nityaasha’s Type 1 Diabetes children and the cheque of Rs.1.5 lakhs was handed over on the same day. In this program, we also felicitated the Nityaasha Children who won the prizes for the Drawing Competition & Speech Competition held on the occasion of World Diabetes Day 2023.
- The 5th Diabetes Education session in collaboration with Kalyani Endocrine Clinic was conducted on 27.01.2024 at the Conference Room, Lunkad Skyvista. 20 T1D children along with their parents attended Carbohydrate Counting and Insulin dose titration and different calculations and practical sessions.

- On 2nd February 2024, a part educational aid for 2 T1D beneficiaries - Ms. Sanika Londhe -T1D youth pursuing a Bachelor of Pharmacy & Ms. Utkarsha Shinde -a T1D youth pursuing Bachelor’s in Engineering for higher education was granted and supported by Mrs. Nasima Merchant, Founder & Trustee.
  - The 6th Diabetes Education session in collaboration with Kalyani Endocrine Clinic was conducted on 17.01.2024 at the Conference Room, Lunkad Skyvista. 18 T1D children along with their parents attended the sessions.
  - On 17.01.2024, Ms. Subhashini attended a Preventive Health Check-up for women organized by the Gyaan Ruchi in coordination with CAAA (Cancer Patient Aid Association) at Upper Indira Nagar, Pune.

- On 8th March 2024, Mrs. Subhashini & Mrs. Hema attended the Women's Day program organized by Mrs. Nasima Merchant, Director - Messung System Pvt. Ltd, Founder & Trustees Nityaasha Foundation & Gyaan Ruchi.
- On 18th March 2024, Mr Farook Merchant & Mrs Subhashini Naorem attended an online meeting with Ms Tanya Singh, from the William J. Clinton Foundation. They would like to know the overall process of Nityaasha working with the T1D Community.
- Mrs. Subhashini and Mrs. Hema visited Chellaram Hospital in Bavdhan, Pune, on 22nd March 2024, to discuss referring needy children with Type 1 Diabetes. 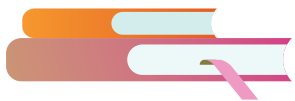
